BASIC RACE RULES

- Race will take place rain or shine.
- Timing of the races will follow a tight schedule. It is the responsibility of each team to ensure they are available for each race they are scheduled for.
- Non-compliance of these rules will mean disqualification;
- No refunds will be given for disqualification.
- I agree to pay for any repair or replacement costs in the event of damage to the boat or equipment.
- No alcohol or drugs before or during the race period.

The following safety rules are important to understand. Please read carefully.

1. I have been provided with a life jacket and understand that it is my own decision if I do not wear it. The life jackets should be kept in the waterproof bag if not worn. If one inflates in anything other than an emergency situation then I agree to pay 50€ for a rearming kit.
2. The weather conditions can worsen very quickly. If contacted and asked to return to the marina, this must be done as quickly and safely as possible.
3. The J70 has a draft of 1.45m. You will not be able to go close into shore. The navigational warning marks must be adhered to.

PLEASE READ CAREFULLY: WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in PMYC Women's Match Race, the undersigned:

- Acknowledge and fully understand that each participant will be engaging activities that involve a risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- Release, waive, discharge and covenant not to sue the volunteers and organizers of this event, if applicable, owners and leasers of premises and leasers of equipment used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability to each of the undersigned, his or her next of kin for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
- In submitting this entry, I, intending to be legally bound for myself, my heirs, executors and administrators, waive, release and forever discharge any and all rights and claims which I may hereafter accrue to me against Adriatic Marinas and related companies, event organizers, event volunteers, and their offices, directors, agents and successors.
- This waiver/release shall be governed by and construed in accordance with laws of the Republic of Montenegro and all disputes and claims arising hereunder shall be subject to the exclusive jurisdiction of the Municipal court in Kotor.
